To ensure the proper use and maintain the integrity of these symbols, please adhere to the following guidelines.

Section 1: RSAG Accreditation Seal



1.1 Purpose: The RSAG Accreditation Seal is designed to identify your company as an RSAG-accredited provider and demonstrate your adherence to our rigorous standards and Code of Conduct.

1.2 Appearance: The RSAG Accreditation Seal should always be displayed in its original colors and proportions. Do not stretch, distort, or modify the seal in any way.
